**PURPOSE:**

**ELIGIBILITY:**

To be considered for this award, the nominee should:

1. Have an approved Forestry Plan
2. Have an ongoing record of forestry practices or contributions

**ORDER OF ENTRY:**

To make a nomination for an award, the District should:

1. Notify the nominee that the nomination is being made.
2. Contact the District Forester to confirm a Forestry Plan is in place.
3. Present in narrative form of no more than 500 words (12 point font) an explanation of what the nominee has accomplished or contributed to forestry. Please include any organizations, associations or boards on which the participant has served. Also provide, no more than ten, pictures to highlight points of forestry practices, public appearances, etc.
4. AISWCD by-laws require that only Districts in good standing are eligible to complete this award.

**AWARD PACKAGE:**

1. Two (2) complimentary meal tickets where award will be presented
2. A plaque of recognition
