## HILLARD MORRIS, 1921-2012

Illinois' Conservation Family lost a good friend on March 15, 2012. Hillard Morris devoted most of his life to the conservation ethic and to the education of our youth about the importance of conservation and protecting our valuable natural resources.

Among his proudest accomplishments was serving on the 30 member task force appointed by Governor Ogilvie in 1972 to develop a Master Plan for Environmental Education. That plan, the original for the state, still exists in its updated form and is used and for many years following his efforts had gone into helping Illinois Soil and Water Conservation Districts and interested groups developing local conservation and education committees starting Conservation Education in their schools and developing outdoor school sites and conservation environmental areas. He was instrumental in establishing the Ballard



Nature Center which has become a well used education facility in the region.

Hillard served as a director of the Effingham County Soil & Water Conservation District for 40 years and was chairman for 34 years. During that time he was also an active member of the Association of Illinois Soil & Water Conservation Districts, serving as a Board Member, a member of the Legislative Committee, Chairman of the Forestry Committee, Vice President and President for seven years (1964-1971).

Hillard's concern for conservation took him to the national level where he served on the National Association of Conservation Districts (NACD), Board of Directors for six years from 1975 - 1981. While serving with NACD, Hillard was also an active member of NACD's District Operations Committee, Recreation and Youth Committee and Education Committee.

Hillard also helped organize the Illinois Woodland Owners and Users Association in 1983 and served on their board for many years.

In addition to his many other awards, Hillard was presented with an Illinois EPA Award in 1974 for involvement of a citizen in Environmental Education and in July of 1975 he was named Illinois' Outstanding Soil & Water Conservation District Director, an award given for the first time by Prairie Farmer and the Association of Illinois Soil and Water Conservation Districts.

Hillard Morris set a very high bar as an example of an agriculturalist and a community leader who was dedicated to the conservation of our natural resources and the education of our youth. He will be missed.

#### -IUM-

The Illinois Urban Manual Steering and Technical Review committees met on Thursday, April 19 in Normal, IL. Both meetings were filled with great ideas and discussion. Thank you to all who were able to attend. It was a pleasure to finally meet you all and place a name with a face.

A new urban standard was approved by IEPA and has been updated on the IUM website. Go check it out: <u>Silt Fence 920</u> – Drawings <u>620A</u>, <u>620A(W)</u> & <u>620B(W)</u> and Material Specification <u>Geotextile 562</u>.

Currently, the Steering Committee has approved *Silt Curtain-Floating 917* to be submitted to IEPA for final acceptance and approval. The group is awaiting a response from IEPA. As far as other standards go there are approximately six to seven that will be considered for updating at the next meetings. Meetings are scheduled for end of May and beginning of June.

#### -PDSWRS Work Group-

The Post Development Stormwater Runoff Standards work group met on Thursday, April 26 at the IEPA with a call-in option. The work group meeting began at 1:15 pm and concluded at 4:20 pm. Great discussion and brainstorming took place. The group compiled a list of key components needed in order to develop the recommendations. ## The White Oak



Rainfall was abundant in the summer of 1848 and the white oak acorn crop was bountiful. Every squirrel in the vicinity spent much of the autumn industriously stashing acorns for the upcoming winter months. One such buried acorn was never sniffed out and in May 1849 it sprouted and pushed up through the leaf litter - reaching towards the life-giving sunlight.

On a winter day in 1867 a bright white and black Downy woodpecker, zygodactyl toes firmly wrapped around the oak sapling's trunk, drilled busily as he searched for larvae snugged beneath the bark. He was lucky and filled his stomach; and often returned to that same spot to chisel away.

A grey squirrel noticed the chiseled area in 1879 and took immediate advantage of the situation. She worked to enlarge the woodpecker holes, and after a frantic chase and a successful mating, settled own to raise a family of three in the growing white oak tree.

A pair of majestic pileated woodpeckers, one of the few still in the area, usurped the squirrels in 1898. They hatched two young woodpeckers but a little boy with a new slingshot killed both fledglings on a sultry summer afternoon.

The raccoon coat craze of the 1920's era caused a wise old mother coon to use the secluded white oak tree as a den site. She sprung four baby coons on the unsuspecting crawdad populations in the spring of 1921.

Encroaching civilization in the fall of 1936 caused the white oak to become a tree in a family house yard. Many of the surrounding oaks and hickories were cut down to make room for the new homes that were ordered from the fat Sears and Roebuck Catalog.

A treehouse was built in a sturdy crotch of the white oak tree in 1949. Materials salvaged from an old barn by an industrious 10-year old boy named Bill created a leafy retreat far from the world of homework and pesky sisters - high among the boughs of the friendly white oak tree.



The beginning of the end took place in 1953. On a humid May night, a spectacular electrical storm exploded. The white oak tree took a direct hit.

Heavy snow during the winter of 1978-79 burdened the already weak oak limbs.

By May 2012, abundant rainfall once again blessed the area. The white oak staggered under the weight of fresh leaves. At 3 a.m. on May 28th, the tired old oak finally gave up and crashed - silently - back to the earth from which it came forth. No one heard it fall. One hundred and sixty-three years of providing a home for birds and bees; of selflessly giving shade to the earth; of creating a secret dreaming place for a young boy; of holding the soil with its roots; of slowing the wind; and of delighting the eye of man came to an end.

What do we lose when we lose a tree? We lose our world, piece by piece. Plant a tree in May this year....and every year after.

# NASA'S LANDSAT SATELLITES SEE TEXAS CROP CIRCLES -- OF THE IRRIGATION KIND

A water-rich polka dot pattern takes over the traditional rectangular patchwork of fields in this time series animation of 40 years of Landsat images. In the dry Texas panhandle near the town of Dalhart, this transformation is due to center-pivot irrigation, a farming method that improves water distribution to fields. It was invented by farmer Frank Zybach in 1949. Center-pivot irrigation works by pumping water from the center of the field through a long pipe that rotates above growing crops like the hand of a clock. Evenly spaced sprinklers along the pipe deliver water with minimal loss to evaporation. Farmers like center-pivot irrigation because it works with a variety of soil types and it can be used on slopes where other gravity-driven forms of irrigation cannot.

As it caught on in the United States and abroad, it revolutionized agriculture since the system can be adapted to a wide variety of terrains and is more efficient with water and labor than other forms of irrigation. Together, all types of irrigation water 20 percent of cultivated fields worldwide, and those fields produce about 40 percent of the global food supply.

In this time series animation, vegetation appears red and the bare soil of fallow fields or sparsely vegetated grasslands appear white to green. The blue-gray X near the center of the images marks the town of Dalhart.

This series uses data from four Landsat satellites. Shown in this false color composite is light reflected from the near-infrared, red, and green regions of the electromagnetic spectrum (bands 4, 2, and 1 from the Multispectral A water-rich polka dot pattern has taken over from the traditional Scanner Systems (MSS) aboard Landsat 1, 2, and 4, rectangular patchwork of fields. The Landsat satellites have provided scientific data on Earth's land surfaces for the past 40 years: Landsat 1 from 1972 to 1978; Landsat 2 from 1975 to 1982; Landsat 3 from 1978 to 1983; Landsat 4 from 1982 to 1993; and Landsat 5 for a record-breaking 28 years from 1984 to what was likely its last data downlink in 2011.

Currently, Landsat 7, launched in 1999 is still providing data. The data from Landsat satellites has been instrumental in increasing our understanding of forest health, storm damage, agricultural trends, urban growth, and many other ongoing changes to our land.

NASA and the U.S. Department of the Interior through the U.S. Geological Survey (USGS) jointly manage Landsat, and the USGS preserves a 40-year archive of Landsat images that is freely available data over the Internet.

The next Landsat satellite, now known as the Landsat Data Continuity Mission (LDCM) and later to be called Landsat 8, is scheduled for launch in January 2013.

Editor's Note: The wells near Dalhart in north-west Texas near the Oklahoma boarder draw water from the Ogallala Aquifer which is being rapidly depleted. Between 1980 and 1995, the level has dropped more than 40 meet in that part of the aquifer and some scientists believe that the aquifer around Dalhart will be completely depleted in the next 25 - 30 years at the present rate of use. Without proper care, the problem of depleted aguifers could affect parts of Illinois as well.



Have you ordered your SWCD license plate yet? For many years, since the "Environmental" license plate first appeared, soil and water conservation districts have been talking about getting a specialized plate to promote soil and water conservation efforts in Illinois. With the passage of HB 4966 sponsored by Representative Chapin Rose that discussion became reality. Public Act 96-1377 was signed July 29, 2010 allowing any Illinois resident to request a soil and water conservation district license plate for their automobile or light truck. That law will expire September 28, 2012.

We hope that when the crops are in farmers and their families will have a little time to think about other things and we hope they will think about supporting soil and water conservation in Illinois. The money from the orders and \$25 from the sale of the plates will go to support the Illinois Envirothon, a very worthy cause.

To order a plate, interested persons need only complete a short form and mail it along with a nonrefundable \$25 deposit to secure their order. The funds will be used for the Illinois Envirothon whether there are sufficient orders to print the plates or not. In order for the Secretary of State to make the first printing, 1,500 plates must be ordered. Once that number has been reached, the Secretary of state will ask for a design to be submitted and if it is found to meet legal requirements then the first run of plates will be printed.

Only sixteen plates need to be orders in each of Illinois' 97 soil and water conservation districts to meet the minimum so be sure to get your plates ordered now and ask your friends and customers if they will consider supporting soil and water conservation in Illinois. They are going to have to buy a plate or sticker anyway. They might as well make it a plate that supports a great cause **AND** promotes soil and water conservation.
