- Describe the district's involvement in the Envirothon. Send pictures of the event.
- Do you have statistics on how many tons of soil was saved due to the implementation of BMPs on farmland or urban land? If so, include that information in your report.

If you have already completed a similar report that has the above information listed, please forward it to me along with photos. A Legislative Book filled with text will not be as appealing as one filled with photos of district activities. If you have any questions on what is needed, please give me a call or send me an email!
