Call-to-Action – Communicate with Legislators

AISWCD would like to remind Districts how important it is to continue to reach out to Legislators and inform them of current District events, current legislative and financial needs and future concerns and needs. Please remember to invite your local Legislators to field days, outreach and education events or visit their office on a monthly basis.

Your District can never provide too much information to the legislators. Listed below are a several talking points that you may want to discuss with your legislators during the upcoming months.

 Importance of Districts keeping their current structure – say NO to Consolidation

 Many Districts are currently sharing employees, both technical and administrative, over county lines

- $_{\odot}$ Over 1/3 of the Districts have only one employee
- Funding is key to survival include SWCDs in the proposed monthly budget
- District employee insurance stress the importance of SWCD employees keeping the CMS-State of Illinois health insurance plan
- Nutrient Loss Reduction Strategy Districts have been named almost a dozen times in the NLRS document to assist with achieving the 45% reduction of phosphorus and nitrogen by the year 2025.
 - "The 97 local SWCDs throughout Illinois play a key role in fostering locally-led conservation work in rural and urban areas"
 - "The SWCDs are a very important asset in the delivery of IDOA's soil and water conservation programs to rural and urban customers. They also assist the USDA Natural Resources Conservation Service (NRCS) in the construction of conservation projects through various programs authorized by the U.S. Farm Bill"
- Also share and invite them to any local field day events or meetings your District is hosting.
