# **2017 CONSERVATION FARM FAMILY AWARD**

### **SPONSOR:**

AISWCD, Brownfield Network, IL Stewardship Alliance, Brandt\*, Prairie Farmer, and Meijer

### **PURPOSE:**

The object of this award is to provide recognition to an outstanding conservation family in each Illinois Soil and Water Conservation District that exemplifies **Total Resource Management**. Therefore, each SWCD is encouraged to sponsor a local contest and submit their winner for Council competition.

From the 16 Council winners the AISWCD Awards Committee will select a Governor's Award winner. Selection will be completed prior to and announced at the AISWCD Annual Meeting/BLWR Summer Conference.

### **ELIGIBILITY:**

1. Open to all landowners and/or operators who are soil and water conservation district cooperators.
2. Previous LUC winners will be eligible to reapply in the fourth year following their selection as a winner (e.g. winner in 2013 or prior can reapply in 2017).
3. Former Governor's Award winners are permanently ineligible.
4. AISWCD By-laws require that only districts in good standing with the AISWCD are eligible to compete at the state level competition.
5. Entry includes information on all land operated by the owner-operator or the tenant operator.
6. Only complete entries will be accepted.

### **ORDER OF ENTRY:**

Entries should be typed, submitted in a 3-ring standard binder, for 8½ inch x 11inch paper with all supporting materials in correct order put into plastic page protectors. Unusual circumstances will be scored at the discretion of the judges with all decisions final.

- ❖ Completed, signed entry form
- ❖ Section 1 - Nominee & Land Overview
- ❖ Section 2 - Conservation Activities - aerial photos of fields delineated out and a copy of the nominees/landowners FSA 1026A.
- ❖ Section 3 - Overall Farm Efforts
- ❖ Section 4 - Signed and typed nominee's essay, not to exceed 2 pages, single spaced, 12 point font. Must address in separate paragraph (25 words or less) nominee's conservation philosophy.
- ❖ Section 5 - Typed and signed Soil & Water Conservation District letter of support, not to exceed 2 pages, 12 point font explaining how nominee(s) has contributed to your local conservation efforts and overview of nominee's general farm husbandry.
- ❖ Section 6 - 8 to 10 color photos showing family, homestead, conservation practices, etc. with narratives displayed in binder. Photos submitted must be jpg, bmp or tiff format on USB drive along with narration in a Microsoft Word document. Photos placed in PowerPoint or Word document will be accepted if pictures can be cut/pasted into another document.

***Please note: The more information that is given in the narratives allows us to prepare a more complete script that is presented at the Farm Family Banquet.***

## **JUDGING**

### **▶ District**

Each SWCD should submit their Conservation Farm Family from the entries received at the local level. Only entries completed on the current entry form will be accepted. Entry must include items listed in "Order of Entry" found on page 1 and 2. Districts may announce their Conservation Farm Family after local selection.

**DEADLINE: May 15, 2017** - Entries to Land Use Council Chairman

### **▶ Land Use Council Judging**

*If more than one (1) entry per Council is received, judging will be performed by an adjoining Land Use Council of their choice.* Entries posted after the deadline date will be disqualified.

Each LUC Chairman is responsible for:

- Selection of a judging committee. The judging committee should consist of at least three members from the following groups but not limited to: District Employee, District Conservationist, SWCD Director, LUC Rep., Area Forester or Biologist.
- The judging committee is responsible for selecting one entry to represent the LUC at the state level and signing entry.
- Notify AISWCD of the LUC winner immediately following LUC selection and send binder to the AISWCD office by: **June 1, 2017.**

### **AWARD PACKAGE:**

Each of the 16 Council winners will be honored at a hospitality hour and awards banquet during the AISWCD Annual Meeting/BLWR Summer Conference on Monday, July 24, 2017. During the conference each council winner (only one family per entry) will receive the following:

- One night's lodging-Monday night- (one room)
- Four (4) complimentary award banquet tickets
- A plaque of recognition
  - *It will be the responsibility of the SWCD to pay for additional plaques if nominee consists of more than one person/family.*
- The overall winner will receive the "**Governor's Award**" during the awards banquet.

### **Governor's Award Winner:**

The Governor's Award winner will also be honored at the 2017 Illinois State Fair\* where they will receive a personalized "Conservation Farm Family" sign for display at their home. This date is still undecided. The winning family will be notified at the Farm Family Banquet.

The winning family and SWCD will receive the following for Illinois State Fair entrance:

- Family = 8 Fair Passes and 2 Parking Passes\*
- SWCD = 5 Fair Passes and 2 Parking Passes\*

e. Demonstrates good stewardship such as placing conservation easements on land, allowing public and multi-use access, building trails, maintaining wildlife habitat	
f. Participates in educational programs such as 4-H, allows tours or conducts demonstration events, participates in the community including donating to food banks, schools, or contributing to other groups or other events	
g. Demonstrates leadership by participating in community, government, and nonprofit or grassroots groups and furthers their work

- Signed and typed nominee's essay not to exceed two pages, single spaced, with 12 point font. Signed and typed nominee's essay, not to exceed 2 pages, single spaced, 12 point font. Also include (25 words or less) in separate paragraph nominee's conservation philosophy.

#### **SECTION 5: SWCD LETTER OF SUPPORT**

- Typed and signed Soil & Water Conservation District letter of support, not to exceed 2 pages, 12 point font explaining how nominee(s) has contributed to your local conservation efforts and overview of nominee's general farm husbandry.

#### **SECTION 6: PHOTOS AND NARRATIVES**

- 8 to 10 good quality, color photos showing family, homestead, conservation practices, etc. with narratives displayed in binder. (Photos will be enlarged for PowerPoint presentation.)
- Photos submitted must be jpg, bmp or tiff format on USB drive along with narration in a Microsoft Word document.
- Photos placed in PowerPoint or Word document will be accepted only if pictures can be cut/pasted into another document.
