ADDITIONAL SPACE

Dave and Holly Purchased the property in Sept of 2014. Farm is +/- 55 ac, located near the NE corner of McDonough County. Property consists of 31 ac recently enrolled in the Forestry Program, and the balance 24 ac of prairie and scrub brush. Shaw Creek runs through the middle of the farm, creating many draws and hill sides, along with a small flood plain on the East side of the creek. There is a small 5-ac tillable field in the SE corner, that has been in Alfalfa the past 20 yrs. 10-1/2 ac of trees (Black Walnut, Burr, Sycamore) were planted in '99 through the CREP program, along w/ a 12 ac easement of forest/prairie attached. They spend their winters eradicating non-desirable trees: the most of which include Box Elder, Maple, Honey Locust, and Hedge; and also under-story invasives; mostly Honeysuckle and a little Autumn Olive. In the Fall, they collect various nuts from existing trees on the farm, stratify in their fridge over winter, then the seeds are potted in early March. Dave and Holly then plant the saplings (as time permits)

over the growing season.

Trees planted to include: various Oaks-white, burr, beech, swamp-white, chinquapin, red & black; and also Shagbark Hickory & Pecan. Black Walnuts are very populous on their farm so they just step the nuts into the ground rather than gathering to pot This past February, they ordered a few trees from Mason County Nursery; 100 Bald Cypress to plant in our moist areas, and 100 Hazelnuts to plant on a South facing hillside. Four smaller scale projects they have going on are:

1.) Most recently, they started a small orchard of Chinese Sweet Chestnuts, in hopes of marketing them in the future.

2.) Next are three bee hives, but it's been an upward battle.

3.) They have gained control of a 1/4-ac of wild Blackberries, and pick about 30-gal a year for marketing and making jam.

4.) They have planted 16 fruit trees for consumption which include Apples, Pear, Plum, and Persimmon.
