The AISWCD was hard at work this past spring advocating on the behalf of Soil and Water Conservation Districts. With a change of administration and nearly one third of the General Assembly being freshmen legislators this spring, AISWCD fast set to work to meet with new policymakers to educate them on the work of conservation districts and share AISWCD policy goals. AISWCD engaged influential members of each legislative chamber, testified before lawmaker committees, prepared and presented policy memos with recommendations to officials, and interfaced with the Governor's Office.

The results of this spring session can be described as nothing but fantastic lawmakers were discussing concepts such as cover crops, soil health, and nutrient loss reduction.
