### MESSAGE FROM THE DIRECTOR OF AGRICULTURE

Dear Partners and Friends,

Illinois' Soil and Water Conservation Districts are the multi-tool in our toolbox because of the hard work you put in every day. This year has been tough on everyone across our nation and our state. With the uncertainty we have all faced, it's comforting to know our agriculture community can count on you to keep watch over our land and water.

This past year the Department launched the Fall Cover for Spring Savings premium discount program. Our inaugural season resulted in an additional 50,000 acres of cover crops planted in the State with 70% of applicants identified as planting cover crops for the first time. We encouraged farmers to take this program into consideration when making fall planting decisions and the response was overwhelming.

I want to also commend the hard work S.T.A.R. (Saving Tomorrow's Agriculture Resources) has done in the past year. S.T.A.R. is a prime example of how a tool developed by Illinois farmers can help encourage improvements in on-farm soil health and downstream water quality.

In August, S.T.A.R released their annual report for the 2019 growing season. The strides taken by S.T.A.R to give farmers flexibility in choosing their path to conservation success will translate into environmental impacts that we will see in our farming communities.

IDOA looks forward to another year working jointly promoting innovative forms of agriculture protecting Illinois' vital resources, water and soil. Congratulations on a great 2020 and the Department looks forward to working with you in 2021.


I am pleased to share this annual report with everyone. We are optimistic that 2021 will be a much better year.

### NACD ANNUAL MEETING


AISWCD REPRESENTATIVES AND STAFF ATTENDED THE NATIONAL ASSOCIATION OF CONSERVATION DISTRICTS (NACD) ANNUAL MEETING IN LAS VEGAS DURING FEBRUARY 2020.



The Illinois delegation to the NACD Annual Meeting brought with them a resolution urging NACD to recognize the Saving Tomorrow's Agricultural Resources (STAR) initiative. The resolution passed unanimously with strong support from several supportive states. This major accomplishment was the first national recognition of the novel sustainability initiative. NACD HAS MADE THE DECISION TO TAKE ITS 2021 MEETING, SCHEDULED FOR FEBRUARY 2021, TO AN ONLINE FORMAT TO REDUCE THE HEALTH RISKS TO THE MANY ATTENDEES TRAVELLING FROM ACROSS THE COUNTRY.

#### ANNUAL MEETING & SUMMER TRAINING CONFERENCE

THE SITUATION INVOLVING COVID-19 MADE IT IMPOSSIBLE TO SAFELY MEET IN PERSON, HOWEVER, AISWCD PIVOTED AND TOOK THE EVENT VIRTUAL TO ACCOMPLISH KEY ASSOCIATION GOVERNANCE MATTERS.



Due to the magnitude of the COVID-19 Pandemic, the AISWCD Board of Directors made a difficult decision to cancel the 2020 Summer Training Conference. The health and safety of the AISWCD's membership and partners were paramount to this decision. The AISWCD, however, held a virtual Annual Meeting to conduct official business. The 2021 Annual Meeting and Summer Training Conference is tentatively scheduled for July 2021.

#### AISWCD STRENGTHENED ITS SUPPORT OF THE SAVING TOMORROW'S AGRICULURE RESOURCES INTITIATIVE THROUGH COLLABORATIVE EFFORTS WITH THE STAR STEERING COMMITTE



AISWCD strengthened its ties with the Saving Tomorrow's Agriculture Resources initiative. This initiative provides Illinois farm operators and landowners a means to evaluate, measure and increase their use of conservation practices. The Association collaborated on STAR's steering committee and offered communication and outreach support.

The Association also worked with the committee to hire Nick Longbucco as the new fulltime STAR Coordinator via a grant funded opportunity. Nick looks to expand STAR throughout Illinois, engaging with more county conservation districts and farmers to increase the use of STAR's free evaluation tool. With increasing consumer demand for sustainability produced food and fiber products, STAR is a great way for Illinois' farmers to demonstrate how they are protecting valuable soil and water resources. 
